- 7:45 am Depart for Tour of Palouse and Eastern Washington, with stops at:
- (1) Emtman Bros. Farms The Emtman family has been raising canola ever since the crushing plant was built at Warden in 2012. They average 2500-3500 acres each year, and have about 4500 acres of alfalfa and timothy that are raised for hay. Cattle is also part of the operation, with enough to process and sell farm direct about 65 head per year. https://www.emtmanbrothersfarms.com/story
- (2) Steptoe Butte State Park overlook a 360° view of the Palouse!

- (3) Viterra crushing plant in Warden, WA.
 - * Those not attending the plant tour will have lunch with the entire group in Warden and then go directly to the Dewald farm and perhaps another farm in the area.
- (4) Dewald Farms Rob is the 4th generation farming where his great grandfather homesteaded in 1889. His kids are 5th and grandson is the 6th generation. Rob has been raising canola since the late 90's, and it has been very challenging over the years, as has direct seeding. They started direct seeding in 1996 at Ritzville and went 100% in 2002. Crops include winter wheat, winter canola, winter peas, winter triticale, and they have also raised spring peas and spring canola together, sunflowers, cover crops, companion crops, mustard, sorghum, and plenty of Russian thistles over the years.
- (5) Rosenhoff Homestead Ron Jirava is the 6th generation on the farm that was homesteaded in 1882. They started changing cropping practices in 1986 by growing both winter and spring canola, and in 1996 started changing tillage practices by investing in a no-till drill. Also in 1996 WSU agreed to work with Jirava's on long-term, alternative cropping systems. They have grown continuous wheat on 480 acres since 1996 as well as in the research plots. The plots have had a mix of crops and rotations including barley, spring and winter canola, mustard, safflower, triticale, all with varying success. The rest of the farm has been mostly winter wheat summer fallow but fall planted peas are being introduced into the rotation.
- (5a*) Gust Farms Randy Gust farms 15 miles south of Ritzville as a fourth generation farmer. He has grown winter canola for three years in a summer fallow/wheat rotation, and has also tried spring canola, spring wheat, and triticale over the years. Randy has observed some interesting differences between seeding dates this fall that he is looking forward to sharing with the tour group.

- (6) Curtis & Erika Hennings farm for a reception/dinner prior to traveling back to Spokane in the evening.
- *** 2019 marks the 30th anniversary of the founding of the USCA. Curtis was the first president of the USCA, and attended the founding meeting of the Association. Curtis is a third generation farmer and started oilseed production with rapeseed in 1984, and winter canola in 1986. They also grow winter wheat, winter triticale, spring canola, sunflower, and camelina. When there's a market for an alternative crop, Curtis is willing to try growing it, and that has included safflower, soybean and even fenugreek! Both of their adult children, Hans and Elena, are actively involved in the farm operation. When he was interviewed by WSU for a case study, Curtis stated "I definitely consider growing canola a successful venture when four out of five years I've made more money off canola than winter wheat."
