Dear Speaker Boehner and Leaders Reid, Pelosi and McConnell:

After an almost five-year delay, members of Congress will finally have an opportunity to vote to implement the U.S.-Colombia Free Trade Agreement (FTA) in the coming weeks. The delay in implementation of the FTA has cost U.S. agriculture dearly in lost sales and market shares. But a favorable vote can re-establish our competitive position in the Colombian market. The undersigned groups, representing virtually the entire food and agricultural sector, urge you to cast that vote.

For U.S. crops, Colombian import duties under the FTA will be immediately eliminated for wheat and malting barley, soybeans and soybean meal, corn starch, nearly all fruits and vegetables, peanuts and products, tobacco and cotton. For U.S. livestock products, Colombian import duties will be immediately eliminated for high-quality beef, some pork products such as bacon and pork skins, most kinds of poultry and a range of dairy products.

For many other crops and livestock products, tariff-free access will be provided immediately under specified levels (tariff-rate quotas), which will expand over time. Colombia will also immediately eliminate for U.S. products its system of applying variable tariffs below its WTO bound rates, which can be as high as 388 percent. This "price band" system is currently applied to imports of corn, rice, wheat, oilseeds and products, dairy, pork, poultry and sugar.

In addition, the vast majority of processed food products will receive immediate duty-free treatment. Colombian duties on imports of even the most sensitive agricultural products from the United States will be completely phased out over a period not to exceed 19 years.

Since the FTA was signed in 2006, these benefits have instead accrued to our competitors. U.S. agricultural exports to Colombia in 2010 were at the lowest level since 2005. The U.S. share of Colombia's agricultural imports has fallen from 81 percent to 19

percent since 2008. Major agricultural exporting countries, such as Argentina and Brazil, already have preferential access to this market. To make matters worse Colombia's FTA with Canada went into force on August 15, and it is on the verge of implementing a FTA with the European Union. Our share of the Colombian market in wheat, feed grains and other products will plummet even further unless we act promptly to correct these inequities by passing the U.S.-Colombia FTA.

It is not too late to remedy the situation and recapture our fair share of that market. American producers can compete with anyone in the world if the playing field is level, and implementation of the Columbia FTA would do just that. It would not only make us competitive with other supplying countries, it would also achieve a fair balance in our bilateral relationship, under which 99 percent of Colombian agricultural products have entered the U.S. duty-free under the Andean Trade Promotion and Drug Eradication Act.

The preferential market access benefits this agreement will provide U.S. food and agricultural producers will create U.S. jobs and strengthen rural economies. According to the American Farm Bureau Federation, the U.S.-Colombia FTA would result in U.S. agricultural export gains of more than \$370 million per year at full implementation. This export growth would generate some 3,100 new jobs here at home, according to USDA. A study by a group of noted economists for the Agricultural and Applied Economics Association puts the number at closer to 5,900 new jobs.<sup>1</sup>

Colombia has undertaken important changes in its domestic policies to correct problems identified by members of Congress. The undersigned organizations believe that a strong and mutually beneficial relationship between our two nations, rather than continuing to withhold congressional approval of the FTA, will advance legitimate U.S. objectives in these areas.

For all of these reasons, we strongly urge that you vote in favor of the U.S.-Colombia Free Trade Agreement.
